Biographical Sketch

Charles P. Schulze, Jr., son of Charles P. Schulze and Virginia Tucker, was born January 2, 1913. Charles, the elder, was the brother of J. O. Schulze, a co-founder of the City of Irving.

Charles, Jr., attended Irving schools for six years and then transferred to Holy Trinity School in Dallas for one year. He spent three years at Dallas Academy and graduated from North Dallas High School. Mr. Schulze then attended St. Edward's University in Austin, graduating with a degree in business administration in 1933.

After graduation, Mr. Schulze spent a brief time teaching, attending law school, and working for the Pittsburgh Plate Glass Company. In 1935, he went to work for Sun Oil Company, where he remained for ten years.

In 1936, Charles Schulze, Jr. married Catherine O'Connell. Ms. O'Connell, born in 1915, was the daughter of John J. O'Connell and Daisy Potter O'Connell. A native of Dallas, Catherine O'Connell Schulze graduated from Ursuline Academy, then attended Loyola University in New Orleans, graduating in 1936 with a degree in English.

The Schulzes traveled throughout west and south Texas for ten years while he worked for Sun Oil Company. In 1945, the Schulzes moved to Irving so that Charles could join his father in the family lumber business. Irving Lumber Company was founded by J. O. Schulze in 1903. His brother Charles took over the business in 1905 when J. O. returned to his home state of Iowa.

Through the years, the Schulzes were active in civic, social, and church activities. Charles was elected to two terms on the Irving city council, 1951-1955. He ran for mayor, losing in a runoff in 1955. While in office, he was instrumental in promoting the city charter election of

1952. In addition to operating the lumber company, Mr. Schulze was on the board of directors of Irving Bank & Trust. In 1960, he opened Handy House, one of the first retail-oriented home improvement stores in the country. Mr. Schulze was also active in the Irving Chamber of Commerce, serving as its president in the late 1950s, and in the Downtown Association.

The Schulzes were very involved with the Catholic Church. They donated the land for the St. Luke church and school facilities in Irving. Mr. Schulze was on the board of directors of the University of Dallas and Catholic Charities. Mrs. Schulze served as president of the Diocesan Council of Catholic Women and was a member and past president of the St. Luke's Altar Society.

Mrs. Schulze was also the first president of the Junior Irving Garden Club, which later became the Irving Woman's Club and was co-founder of the Irving Symphony League. She was also instrumental in establishing the Irving Heritage Society.

Series Description

The Charles and Catherine Schulze Papers are arranged in five series:

Series I. Personal Documents, 1883-1998. .3 linear ft. (10 folders)
Arranged chronologically. Contracts, deeds, correspondence, invitations, clubs and organizations, remembrances. Photocopies of the documents are in the front of the folder.

Series II. City Government Related Documents, 1940s-1990s. .4 linear ft. (9 folders).
Arranged by type. City council meeting agenda, ordinances, budget material, bond sale notes, incorporation information, DART election material, correspondence, zoning information.

Series III. Publications, 1940s-1980s (bulk 1950s). .7 linear ft.
Arranged by type. Development plans, zoning ordinances, water supply reports, city budgets, charters from Irving and other Texas cities, financial reports on city departments, promotional booklets.

Series IV. Yearbooks, 1930-1931. .1 linear ft.
Arranged chronologically. The Tower from St Edward's University.

Series V. Maps, 1902-1943. 5 maps.
Blueprint of Chicago, Rock Island & Gulf original survey, 1902; plat map of Otis Brown

Addition to Irving, 1906; corrected plat of Irving, Texas, 1909; Otis Brown Addition to Sowers Cemetery, 1926; Road Map of Dallas County, Texas, 1943.

Series VI. Newspapers and Newspaper Clippings, 1903-1960s. .3 linear ft.
Complete issues arranged by title and date. Encapsulated individual articles are in no particular order.

Series VII. Photographs, 1902-1950s (bulk 1902-1920). .2 linear ft.
Arranged in photo sleeves in a photo album. All are black and white, primarily of the survey crew.

Scope and Content Note

The Charles and Catherine Schulze Papers are housed in two manuscript boxes, one oversize box, one cubic-foot box, one photo album, one large map folder, which is located in the Flat File Cabinet, and a newspaper folder that is located in the Newspaper Cabinet.

Series I is a made up of various types of personal documents relating to the Schulze family. The correspondence is mainly to J. O. Schulze seeking information on the Chicago, Rock Island Railway and to Charles Schulze, Jr., relating to city business. Also included are invitations to various openings and dedications, miscellaneous receipts, lists, notes, etc. collected by Mr. and Mrs. Schulze, newsletters and publications relating to clubs in which the Schulzes were members, and remembrances from funeral services.

Notable in this series is the 1905 contract in which C. P. Schulze buys a one-half interest in Irving Lumber Company from J. O. Schulze; a 1905 contract between the Lively School Board and Irving Lumber Company to supply material to build a school building; and a telegram announcing the birth of J. O. and Agnes Schulze's first son in 1904. Also included are invitations to the dedications of St. Luke's Catholic Church buildings in 1928 and 1954 and an invitation to the dedication of the city hall building in 1956.

Series II consists of documents Charles Schulze accumulated during his tenure in city government. For the most part, these are agenda for council meetings from 1953-1955. Included is a small amount of correspondence, reports on zoning, notes on bond sales, and campaign material from the DART election, 1996.

Series III is made up of bound publications and reports pertaining to city government. Foremost are municipal development plans and Irving's zoning ordinance in various printings from 1953 to 1984. Also included are several water supply reports dating to the early 1950s, the charter of the cities of Irving and Garland, and financial examinations of city departments from the early 1950s. Of particular note are the City of Irving's Annual Budgets from the years 1953 and 1954. Also of interest are two promotional booklets produced by the chamber of commerce in 1946 and 1949 touting Irving's advantages to businesses around the country.

Series IV is made up of two yearbooks from St. Edward's University in Austin, Texas, 1930 and 1931. C. P. Schulze, Jr., graduated from St. Edward's in 1933.

Series V consists of five maps: a blueprint of the original Chicago, Rock Island & Gulf survey map of the section surveyed by Schulze and Brown, 1902; a plat map of the Otis

Brown Addition to Irving, 1906; a Corrected Plat Map of Irving, 1909; a plat map of the Otis Brown Addition to Sowers Cemetery, 1926; and a Road Map of Dallas County, Texas, 1943. All the maps are encapsulated.

Series VI is made up of newspapers and newspaper clippings. Most of the complete issues of the papers pertain to the debate during the 1950s about making Irving Blvd. and Second Street one-way streets.

Complete editions of particular note in the collection are the first issue of the Irving Index, December 19, 1903, and the Irving Index from July 2, 1904, reporting on the post office moving from Kit to Irving. There is also a complete edition of *The Irving Herald* from October 8, 1931. This is the "Progress Edition" containing articles about the businesses of Irving at the time and reflections back to the founding of the city by early local residents.

Also included in Series VI are clippings from various newspapers dating from the 1910s to the 1950s. A large number of the articles pertain to the fiftieth anniversary of the founding of the city, 1953. Included in the clippings is Netta Brown's "History of Early Irving" published in the December 16, 1949, edition of *The Irving Herald*. The clippings have been encapsulated. Photocopies of the clippings have been made and are in the box with the clippings.

Included in the newspaper folder is an architect's drawing of the proposed Senter Park Youth Center, 1954.

Series VII, Photographs, consists of 77 black-and-white photographs. The bulk of the photos are of the survey crew, 1902-1903.

Provenance Statement

The Charles and Catherine Schulze Papers were donated to the Irving Archives by Charles and Catherine Schulze in eight accessions from 1997-1999. Prior to its donation to the Archives, the material was in the Schulzes' possession.

Also included in this box are individual encapsulated newspaper articles clipped from various newspapers, primarily Irving papers, ranging from the 1910s-1960s, with the bulk falling between 1949-1953. A large number of the articles pertain to the activities relating to the 50th anniversary of the founding of the city, 1953. In certain of these articles, Schulze, Brown, R.M. Hudson, and others discuss the founding and early years of the city. The 1950s building boom is another topic addressed in the clips. Netta Brown's "History of Early Irving" published in the December 16, 1949, edition of *The Irving Herald* is included.

Newspaper Folder in Newspaper Cabinet

Several newspapers have been encapsulated in whole. These papers have been placed in a newspaper folder marked "Schulze Papers, Collection 31" and put in the Newspaper Cabinet, Drawer 1. They include:

Irving Index, Vol. 1, No. 1, December 19, 1903. First edition of the Index. There is a hand annotation "First copy off the press." The center of the front page has a large hole in it. The remainder is in good condition.

Irving Index, Vol. 1, No. 28, July 2, 1904. "It Is Now Irving" Post office moves from Kit to Irving.

The Irving Herald, Vol. VII, No. 13, October 8, 1931, Progress Edition. Contains articles on Otis Brown's founding and naming the town; the Northwest Dallas County Civic Association; Robinson's Drug Store; Shadylea Golf Course; and Lone Star Camp for Underprivileged. The "Progress Edition," which consists of sections 2 and 3, is a report on Irving's growth. It contains articles on Irving businesses such as Range Brothers; Irving Lumber; and Irving State Bank, among others.

The Irving News, Vol. 1, No. 51, January 5, 1934. Contains an article about Charles and

Virginia Schulze donating land for a city park.
